# NAHRO Vision and Mission Statements and Values

**Background:** Prior to the Leadership Retreat, the Strategic Planning Advisory Group (SPAG) submitted revised vision and mission statements and values for the Board's consideration and action.

Action: Motion by Akinola Popoola; second by Richard Leco that the Board adopt, as submitted by the Strategic Planning Advisory Group, new vision and mission statements and values, which will replace current vision, mission and value statements. Following much discussion, Board members were asked to cast their votes in writing. Paper ballots were distributed: results: 24 Yeas; 7 Nays. Motion carried.

#### STRATEGY STATEMENTS

Retreat attendees were divided into groups: Each group was assigned strategy statements to examine and decide whether statements should stay the same and/or be consolidated with other strategy statements. Groups were authorized to examine any of the strategy statements not assigned to them. Some groups also submitted "Strategic Ideas," which will be transmitted to the SPAG for consideration and disposition.

Each group submitted/presented both written and oral reports at the retreat. After presentation of each oral report, attendees commented. Then the Board was asked to express its approval/disapproval of the reports/comments. The Board's consensus is reflected in "Goals and Strategy Statements: 2016 Leadership Retreat Changes."

NAHRO CEO Saul Ramirez, Jr., said staff will work with SPAG to revise the strategy statements as agreed upon by the Board. However, in order to have final strategy statements ready for transmittal to committees prior to their meetings in April, the Board would have to, at the retreat, authorize the Steering Committee to take action on SPAG's revisions to the strategy statements on its behalf during its March 30 teleconference.

President Merritt called for motion to reflect what needs to occur prior to committee meetings in April.

Action: Motion by Akinola Popoola; second by Larry Williams that the Board authorize the Steering Committee to consider and take action on the revisions to the Strategy Statements. Motion carried.
