

SUMMARY OF STEERING COMMITTEE TELECONFERENCE: MARCH 9, 2016

President Steve Merritt called the meeting to order. LaTonya Rajah called the roll; a quorum was established.

Action item: Approval of the 2016 Legislative/Regulatory Agenda

CEO Ramirez commented that the congressional relations and program policy teams presented highlights of the agenda at the Leadership Retreat in Ft. Worth. Following which, staff solicited comments from the Board of Governors and Housing and CR&D Committees. Prior to the teleconference, staff presented a revised document to the Steering Committee for its consideration, which included the following changes:

- NAHRO's new mission, vision and value statements;
- Final NAHRO funding recommendations; and
- New language on FMRs as suggested by a Board member: "NAHRO will seek that HUD employ a methodology that accurately captures current rental markets when calculating Fair Market Rents (FMRs)."

During the teleconference, Steering Committee members offered the following amendments:

- Foreword: *include*: a positive, encouraging message on the importance of developing a national housing policy and acknowledge work done by Congress to move HR 3700 out of the House;
- Page 4, #3: change: regulatory reform to regulatory streamlining; and
- Page 4, #4: add: SHARP would significantly ease administrative burdens and increase program flexibility for agencies with 550 or fewer public housing units and/or vouchers.

Motion by Akinola Popoola and second By Regina Mitchell to accept the 2016 Legislative and Regulatory Agenda as amended above. Motion carried

IRGE Vice President Julie Brewen regarding Elizabeth Glenn:

A month ago, Liz Glenn was attending a meeting in preparation for Habitat III in Brussels. She became very ill. Liz developed ketoacidosis from previously undiagnosed diabetes.
