# **Presiding: President Carl Richie**

# IRGE Study Exchange in Darwin, Australia

Vice President Saeed Hajarizadeh presented the committee's resolution, which the committee passed unanimously at its February 8, 2019 teleconference:

# NAHRO Delegation for Study Exchange in Darwin, Australia – August 27-September 3, 2019

**Resolution:** WHEREAS, a Memorandum of Understanding (MOU) that sets forth the terms and understanding between the Australasian Housing Institute (AHI), and the National Association of Housing and Redevelopment Officials (NAHRO) was first entered in 2015 and a Renewal MOU was executed in 2018;

**WHEREAS**, the MOU formalizes the goal of the AHI and NAHRO to build a mutually beneficial collaboration, and through this collaboration, there is an aim to promote opportunities and new ideas by sharing information and events, publications and professional development opportunities to each other's membership, and

WHEREAS, an invitation has been extended by AHI to host a NAHRO Delegation for a Study Exchange in Darwin, Australia, and other surrounding areas in close proximity in conjunction with attending the AHURI National Housing Conference from August 27-September 3, 2019, and

**WHEREAS,** IRGE has a goal to support research into matters of interest and value to other standing committees of NAHRO.

**NOW, THEREFORE, BE IT RESOLVED** that NAHRO supports formation of a NAHRO Delegation for a Study Exchange in Darwin, Australia, and other surrounding areas August 27-September 3.
