We are happy to report on the following HDLI initiatives during the past quarter:

#### **About HDLI**

HDLI is a legal resource for PHAs and other partners in the public and affordable housing agency. It is a nonpartisan, nonprofit membership agency. HDLI membership has been growing with a steady influx of new members in recent months. HDLI currently has more than 270 members, the highest it has seen in many years.

HDLI offers a number of unique legal resources: publishes legal periodicals, prepares annual reviews of important cases affecting housing agencies, publishes an index to HUD regulations, conducts CLE conferences and other educational activities, provides legal training and individualized counseling, sponsors an active list serve, and serves as a friend of the court, or *amicus*, in appropriate cases important to its members. HDLI also acts on a national level to influence the development of statutory, regulatory and case law helpful to housing agencies, often in concert with NAHRO and other industry groups.

HDLI's current Board of Directors consists of 22 seasoned industry attorneys and executive directors from across the country. ## **Online Training**:

HDLI continues to offer comprehensive and interactive online fair housing training available at <a href="www.hdlitraining.org">www.hdlitraining.org</a>. HDLI remains open to further discussing an online fair housing training partnership with NAHRO, which might include deeper discounts for NAHRO members in exchange for NAHRO's active endorsement, among other possibilities.



### **On-site Training:**

HDLI's on-site and regional training programs also continue to be a successful. To date, HDLI has provided fair housing, grievance, commissioners, and "One Strike" training to more than 5,000 public housing agency and real estate developer staff.

### **Publications**

HDLI continues to publish its regular legal periodicals during the course of the year: *The Authority* and the *Index to HUD Regulations*. HDLI's *Index to HUD Regulations* is the only published cumulative index of HUD's title 24 regulations and is a must-have desk reference. It is included in HDLI membership. HDLI's offer to work with NAHRO in jointly marketing the *Index* and offering NAHRO members an exclusive discount remains on the table. *The Authority* is a quarterly compilation of judicial decisions from across the country that affect the public and affordable housing industry.

HDLI offers consulting services, as requested, and works on HUD technical training contracts, currently in the areas of fair housing and grievance training.
