**Highlights**: The Committee discussed the work of the National Housing Framework subcommittee. This included efforts to define the framework and a discussion about how the 2024 Presidential Transition fits into the larger scope of the framework.

**Topic:** Homelessness Subcommittee Update

**Highlights:** The Committee discussed the efforts of the homelessness subcommittee including the work that fed into the development of the 2024 Presidential Transition Report.

**Topic:** Choice Neighborhoods Application and Historic Housing Preservation Comments Conversation.

**Highlights**: The Committee discussed ways HUD could streamline and improve the Choice Neighborhoods Implementation Grant application. This included a small agency set aside and changes to how points are weighted in the application process. The Committee also discussed the Advisory Council on Historic Preservation's draft program comment on accessible, climate-resilient, and connected communities. The Committee

felt it was important that NAHRO make sure the needs of housing providers are adequately balanced with historic preservation requirements.

**Topic:** Discussion of Choice Neighborhoods Application

**Highlights:** The Housing Committee discussed how HUD could improve the Choice Neighborhoods application process. Suggestions for how HUD could improve the process include having a set-aside for small agencies; allow senior sites by themselves to be eligible for the grant; allow for a transfer of units out of the neighborhood; and the committee offered other suggestions.

**Topic:** HOTMA (Section 102 and 104) Phased Implementation **Highlights:** HUD asked NAHRO how feasible a phased implementation of HOTMA sections 102 and 104 would be. The Committee felt that HUD should implement the necessary technology and then have a single date when these HOTMA provisions would mandatorily apply. Additionally, the committee also felt that PHAs should have the flexibility to apply certain provisions early, if they choose.

**Topic:** Creating a Searchable System for Practitioners to Share Best Practices **Highlights:** The committee discussed what a searchable database of best practices should encompass. We discussed what other groups who have similar systems do and what features they have.

**Topic:** Guest Speaker Sipho Simela from Matrix Rental Solutions **Highlights:** Sipho spoke to the Housing Committee about the Housing Choice Voucher program and how supplying data to landlords can help with voucher lease up.

### Highlights:

Topic: PD and Certification Update, LMS Preview

**Highlights:** Julz reviewed the numbers (trainings are right on track with where they were last year) as well as did a surface level review of how the different training types break down financially. Public virtual trainings are the big driver of training income – 73% of the income from trainings have come from public virtual classrooms. Private onsites are next driver, then private virtual. Additionally, Julz did a demo of the LMS. The committee is very excited, and many members hope to be involved with testing soon. We will be launching in January 2025.

Topic: SPAC Outcomes

**Highlights:** The committee discussed the five SPAC outcomes we are tied to. We discussed what we think these outcomes look like from our end – the issue is as we are not the drivers of the outcomes, so we don't know exactly what they mean or want. We identified five individuals who will meet with the other committee chairs to clarify what they have in mind.
